

## **ABA MEMBER LOGO LICENSE TERMS (*Download PDF Version*)**

The American Bar Association (“ABA” or “Association”) is pleased to offer its members a logo (“ABA Member Logo”) that will allow them to proudly display their membership affiliation in the ABA. For the purposes of this license, all those with membership in the ABA may use the ABA Member Logo, regardless of their membership category. The ABA Member Logo signals commitment to the legal profession through membership in the Association.

### **Member in Good Standing**

The ABA Member Logo is owned by the ABA and may be used only by ABA members who are in good standing with the Association for the limited purposes set out below. “Good standing” means that member dues are current and the membership status has not been suspended or revoked for any reason.

### **Where the ABA Member Logo May Be Used**

The ABA Member Logo may appear on business cards, letterhead, envelopes, external and internal communications, webpages, social media, print advertising, email signatures, and direct mail or email solicitations, as long as the ABA Member Logo appears together with the name of the ABA member or members. The limited license to use the ABA Member Logo extends only to advertising related to the member’s practice of law and that complies with the laws and regulations promulgated by the State in which the member practices law or provides professional services promoting the practice of law or the legal profession.

If used on a webpage, the ABA Member Logo must hyperlink to the ABA website at [www.americanbar.org](http://www.americanbar.org).

### **Restrictions on Use**

- An ABA member’s license to use the ABA Member Logo terminates automatically as of the time when (s)he ceases to be a member of the ABA in good standing or (s)he improperly uses the ABA Member Logo.
- The limited license to use the ABA Member Logo may not be assigned or sublicensed.
- Only Members actively engaged in the practice of law or in professional pursuits that advance the practice of law, the delivery of legal services, or the legal profession may use the ABA Member Logo. The ABA Member Logo may not be used in connection with business or personal activities that do not fall within the practice of law or advancement of the legal profession.
- The ABA Member Logo may not be used by non-members or in a manner that indicates that a non-member is affiliated with the Association.
- The ABA Member Logo is not an endorsement or certification of a member’s services, practice, expertise, or competency, and may not be used to indicate or imply in any manner that the ABA endorses, sponsors, or approves of any product or service.

- The ABA Member Logo may not be used in a manner that harms the ABA, its members, or is otherwise unlawful, infringing upon legal rights, harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, invasive of another's privacy, hateful, or racially, ethnically, or otherwise objectionable.
- The ABA Member Logo may not be used in connection with any political campaign whatsoever (except for a campaign for a volunteer position within the ABA).
- Law firms participating in the ABA Full Firm membership program may use the ABA Member Logo on its business cards, letterhead, envelopes, external and internal communications, webpages, social media, print advertising, email signatures, or direct mail or email solicitations. If some of the employees, members or partners of the participating law firm do not have ABA membership, those individuals may not use the ABA Member Logo on their individual business cards, letterhead, envelopes, external and internal communications, webpages, social media, print advertising, email signatures, or direct mail or email solicitations.
- The license only permits the use the ABA Member Logo. It does not license or authorize the use of any other ABA trade logos without prior written approval from the ABA.
- The ABA retains the right to terminate this limited license at any time for any reason.
- The ABA is not liable in any way for losses, damages, fees or expenses arising out of use of the ABA Member Logo.
- The terms of this limited license may be amended by the ABA from time to time, in its sole discretion.

### **Graphic Requirements**

The following rules apply to the appearance of the ABA Member Logo:

- The ABA Member Logo may be printed only in black/white or the specific colors provided in the electronic files.
- The ABA Member Logo may only be reproduced in the approved format that is downloaded from the ABA website with no revisions, modifications, or redesign in any manner.
- The ABA Member Logo may not be combined with, added to, or incorporated into any other logo or design, such as the logo or design for a law firm or business.
